- The Department of Biological Sciences offers a Bachelor of Science in Medical Technology in affiliation with schools of clinical laboratory science (medical technology) that are approved by the National Accrediting Agency for Clinical Laboratory Sciences (NAACLS), in cooperation with the Commission on Accreditation of Allied Health Education Programs. (A full list of these schools can be found in the UNT 2013-2014 Undergraduate Catalog.)
- The College of Arts and Sciences expects students to have completed the Texas State recommended high school program and be ready to enroll in a college level mathematics course. If you are not prepared for this level, the necessary prerequisites will either replace electives or increase the hours required for this degree.

Courses Recommended for Transfer

The UNT Core requirements, with the exception of U.S. History and Political Science, and the College & Major requirements are shown with Texas Common Course Numbering System values only when UNT offers equivalent courses. There may be other courses in transfer that apply toward the specific degree requirement, but those listed are known to apply.

Medical Laboratory Sciences: Other Requirements

- Must maintain a minimum of 2.5 grade point average for upper-division courses in the sciences and an overall 2.5 grade point average.
- A minimum 2.5 UNT and overall (includes transfer) grade point average is required for graduation.
- Students in the department whose UNT or overall grade point average drop below 2.5 for two consecutive semesters will be removed from the program.
- A minimum grade of C in all science and mathematics courses.
- Only two attempts will be allowed for each biology and biochemistry course in the degree.
- Students should consider transferring to UNT prior to the end of their sophomore year. For residency requirements student must complete a minimum of 30 credit hours including 24 advanced hours at UNT prior to attending Professional Training.
- Professional Training: Students complete a minimum of 86 semester hours at UNT (prior to entering clinical training) and a minimum of 12 months of clinical training (for a minimum of 32 semester hours) at any NAACLS-approved school of medical technology to complete the degree.
- Upon graduation, students are eligible to take national examinations given by the American Society of Clinical Pathologists (ASCP) and the National Credentialing Agency (NCA) for Laboratory Personnel. Upon passing the registry examination, the student is considered a certified medical technologist or certified laboratory scientist. The awarding of the degree is not contingent upon students' passing the national board examinations.
- Submission to the program director of a transcript evaluation request, including the name of medical technology school(s) where the student is applying
- Filing, in the program supervisor's office before leaving campus, the name of an accredited medical technology school to be attended.

Special Notes

Hours Required and General/College Requirements: A minimum of 120 semester hours, of which 42 must be advanced, and fulfillment of degree requirements for the Bachelor of Science degree as specified in the "General University Requirements" section of the UNT catalog and the College of Arts and Sciences requirements.

UNT Core Curriculum/Transfer of Core Curriculum: UNT complies with the mandates of the 1997 Texas Legislature regarding requirements for state-assisted institutions. Students who successfully complete the common core curriculum (in whole or in part) at a Texas state-assisted institution of higher education are eligible to transfer as "core complete" for those categories in the UNT University Core Curriculum.

Individual academic programs may require courses contained in parts of the University Core Curriculum. Students who wish to take courses that will fulfill both core and major/program requirements simultaneously should check with academic advisors for assistance in selecting core courses.

Choice of Catalog: Any student transferring directly from a Texas public community college to UNT shall have the same choice of catalog designating degree requirements as the student would have had if the dates of attendance at the university had been the same as the dates of attendance at the community college.

SENIOR YEAR

Before attendance at a school of clinical laboratory science approved by the National Accrediting Agency for Clinical Laboratory Sciences (NAACLS), student must apply and be accepted by the school. A minimum of 32 hours of professional medical technology courses during approximately 12 months is required to complete the senior year of this program. Successful completion of the first three years does not guarantee admission into a school of clinical laboratory science. Contact the Medical Laboratory Sciences Program Director (32 hours total).
